

## 1. Authorship and Contributor ship:

- Criteria for Authorship: Authors must adhere to established criteria for authorship, such as those outlined by organizations like the International Committee of Medical Journal Editors (ICMJE). Individuals who have made substantial contributions to the conception, design, execution, or interpretation of the research should be listed as authors. Contributors who do not meet the criteria for authorship should be acknowledged appropriately.

- Order of Authorship: Authors should collectively agree on the order of authorship based on each individual's contributions to the research. Typically, the first author is the individual who made the most significant contributions, followed by co-authors in descending order of contribution. Honorary or guest authorship, where individuals are included without substantial contributions, should be avoided.

- Corresponding Author: One author should be designated as the corresponding author responsible for communicating with the journal and addressing queries related to the manuscript. The corresponding author must ensure that all co-authors approve the final manuscript for submission and publication.

## 2. Data Integrity:

- Data Collection and Analysis: Authors are responsible for ensuring the integrity and accuracy of research data collected for the study. Data collection should be conducted using appropriate methodologies and instruments, and data analysis should be performed rigorously using valid statistical techniques. Detailed records of data collection procedures and analytical methods should be maintained for transparency and reproducibility.

- Data Presentation: Authors should present research findings accurately and transparently in the manuscript, avoiding selective reporting or manipulation of data to support a particular hypothesis or conclusion. Figures, tables, and other visual representations of data should be clear, accurate, and properly labeled to aid interpretation.

## 3. Conflicts of Interest:

- Disclosure of Conflicts: Authors must disclose any potential conflicts of interest that could influence the research or its interpretation. Conflicts of interest may include financial relationships, personal relationships, institutional affiliations, or competing interests relevant to the research or publication. Authors should provide a transparent declaration of conflicts of interest in the manuscript, including relevant disclosures.

- Management of Conflicts: Authors should take appropriate steps to manage conflicts of interest, such as avoiding situations where conflicts could unduly influence the research or its outcomes. If conflicts of interest exist, authors should disclose them transparently and consider mitigating actions, such as recusal from certain aspects of the research or disclosure of financial relationships.

#### 4. Compliance with Ethical Guidelines and Regulations:

- **Ethical Approval:** Authors conducting research involving human subjects, animals, or sensitive data must obtain ethical approval from an institutional review board (IRB) or ethics committee before initiating the research. Details of the approval process, including the name of the reviewing body and approval number, should be provided in the manuscript.
